The Company hereby respectfully announces to its Shareholders the payment of the 2025 cash dividend as follows:

1. Information on the 3.0% Cash Dividend Payment:

- Dividend Payment Rate: 3.0% per share (each share is entitled to receive VND 300), based on the total number of CQT shares outstanding as of the record date for determining the list of shareholders entitled to receive the dividend, in accordance with the list of shareholders finalized by the Vietnam Securities Depository and Clearing Corporation (VSDC) on August 4, 2026, enclosed with Official Letter No. VNDVCAVSDC020233/VSDCQTX dated 04 August 2026.

CQT will withhold personal income tax at source at the rate of 5% on the dividend amount of individual shareholders to pay to the tax authority in accordance with the law.

- Source of dividend payment: Undistributed profits after setting up funds and profit distribution as of December 31, 2025.
- Record date for shareholders to receive dividends: August 4, 2026.
- Payment date: August 28, 2026.

2. Instructions for Receiving Dividends

- For deposited CQT shares: Shareholders shall carry out procedures to receive dividends at the depository members where their depository accounts were opened.
- For undeposited CQT shares:

Shareholders shall designate their bank account for CQT to make the dividend payment by completing the Application Form for receiving cash dividend by bank transfer (a form is attached herewith) and submitting the original application form together with a valid certified copy of the shareholder's Citizen Identity Card to VVMI Quan Trieu Cement Joint Stock Company at the address specified above.
